ACTIVITIES TOP HOODLUMS, CHICAGO AREA.

REMYTEL YESTERDAY RE SLAYING OF LEO FOREMAN.

CG 6560-PCI ADVISED THAT ON NOVEMBER 14 LAST, AT 7:30 PM HE RECEIVED A TELEPHONE CALL FROM SAM DE STEFANO WHO ADVISED INFORMANT THAT HIS "FAT FRIEND" LEO FOREMAN WAS DEAD. DE STEFANO STATED FOREMAN WAS KILLED FOR TWO REASONS, ONE IN THAT HE OWED DE STEFANO \$7,000 ON JUICE LOANS WHICH HE REFUSED TO PAY, SECOND REASON WAS THAT FOREMAN WAS AN INFORMANT FOR THE FBI IN CHICAGO, ILLINOIS. INFORMANT STATED THAT DE STEFANO INDICATED FOREMAN WAS SUPPOSEDLY SEVERELY TORTURED PRIOR TO BEING KILLED.

INFORMANT STATED HE SAW A CAR RESEMBLING FOREMAN'S 1963 RED CORVAIR RENTED FROM COURTESY MOTORS, CHICAGO, ILLINOIS, ON THAT DATE ON HAMLIN AVENUE, JUST SOUTH OF MADISON STREET. INFORMANT ADVISED THAT MRS. LEO FOREMAN HAD NOTIFIED THE CHICAGO PD THAT FOREMAN WAS A MISSING PERSON SINCE NOVEMBER 14 LAST.

INFORMANT STATED THAT ON NOVEMBER 13 LAST HE OBSERVED CHUCKIE NICOLETTI AT DE STEFANO'S HOME AND HE BELIEVES NICOLETTI IS POSSIBLY RESPONSIBLE FOR THE MURDER OF FOREMAN. INFORMANT STATES THAT ABOUT THREE MONTHS AGO AT DE STEFANO'S HOUSE, FOREMAN, NICOLETTI AND DE STEFANO HAD A CONVERSATION CONCERNING FOREMAN'S

WOLFARTH AUGUST 22, LAST. HE ADVISED WHEREABOUTS OF SMITH. SMITH ARRESTED SEASIDE, CALIFORNIA, AS RESULT. FOREMAN CLAIMED HE PAID SUBJECT'S ^{SMITH'S} WAY TO CALIFORNIA TO BE WITH AILING CHILD. IT WAS NOT HER FAULT SHE DID NOT APPEAR. HE STRESSED HE WOULD ONLY FURNISH THIS INFORMATION, NONE OTHER. FOREMAN, THEREFORE, WAS NOT MADE PCI.

SMITH SENTENCED NOVEMBER 8, LAST, AND SA WOLFARTH ASKED HER IF FOREMAN INVOLVED WITH COUNTERFEIT CHECKS OR MONEY ORDERS. SHE ADVISED NEGATIVELY.

FOREMAN TELEPHONED SA WOLFARTH NOVEMBER 13, LAST. SAID HEARD ABOUT INQUIRY. DESIRED THAT HE SHOULD BE CONTACTED ^RATHER THAN SOMEONE ELSE, NO ARRANGEMENTS MADE TO INTERVIEW FOREMAN.

PRESIDENT, PLAZA DRIVE IN BANK, NORRIDGE, ILLINOIS, NOVEMBER 13, LAST, ADVISED ON OCTOBER 7, LAST, TWO STOLEN AMEXCO MONEY ORDERS DEPOSITED LE FORE COMPANY ACCOUNT IN AMOUNT \$100 EACH. MONEY ORDERS NOT HONORED BY AMEXCO. LE FORE COMPANY CHECK PAYABLE TO LEO FOREMAN FOR \$1000, DATED OCTOBER 21, LAST, LACKED FUNDS FOR PAYMENT.

FOR THE INFORMATION OF THE BUREAU, THE CHICAGO PD IS AWARE OF THE RECENT ARGUMENT BETWEEN ALDERISIO AND FOREMAN. NO INFORMATION CONCERNING NICOLETTI IS PRESENTLY BEING DISSEMINATED TO THE CHICAGO PD AT THIS TIME IN VIEW OF THE DANGER TO THE INFORMANTS LIFE AND DUE TO THE FACT THAT DE STEFANO PERSONALLY ADVISED INFORMANT OF THE MURDER OF FOREMAN.
