 QUOTE WHO IS AN ASSOCIATE OF SAM DE STEFANO AND WAS AN ASSOCIATE
 OF LEO FOREMAN. PIX ALLEGEDLY HAD SERVED TIME WITH FOREMAN.
 PIX INDICATED THAT HE WAS AWARE THAT FOREMAN WAS TO BE KILLED
 SHORTLY BEFORE FOREMAN/S DEATH AND HIS DEATH WAS VERIFIED
 TO HIM ABOUT TWO HOURS AFTER THE KILLING AND BEFORE BODY WAS
 FOUND. PIX INFORMED PCI THAT DE STEFANO HAD CALLED HIM AND
 REQUESTED VERIFICATION OF DENISE NELSON/S ADDRESS IN CALIFORNIA.
 DENISE NELSON WAS ALLEGEDLY A GIRL FRIEND OF FOREMAN AND AN
 END PAGE ONE
