You will recall that we exchanged information verbally concerning the arrest on 22 September 1966 of 13 hoodlums in a Queens, New York, restaurant. In order to identify the names listed in a newspaper article of those arrested at this restaurant, a name-check was made through our Identification Branch.

As a matter of routine, the Identification Branch requested an up-dating of TRAFFICANTE's U.S. record and this is the only reason for our enquiry. There has been no indication that TRAFFICANTE is visiting, or intends to visit, Canada.
