On 3/7/67, NY 4008-C-TE advised Miami SA that on the evening of 2/27/67, SANTO TRAFFICANTE, JR., attended a private party at the Keystone Point, Miami home of JOSEPH FISCHETTI. FRANK SINATRA attended this party. TRAFFICANTE was accompanied by an associate, JOHN J. IMPARATO of Tampa, Fla.

Source advised that IMPARATO was originally from the ANASTASIA "LCN Family" (now the GAMBINO "Family") of New York and is alleged to be a full partner of TRAFFICANTE in all of his interests. IMPARATO recently purchased a 53' boat, he is about 50 and balding. Source stated that their activity in Tampa included narcotics and the waterfront rackets.

IMPARATO resides in Tampa and owns the Southport Terminals, Inc., located at the foot of Grant St., Hooker's Point, telephone 248-6168.
