Re Bureau airtels to Miami dated 7/20 and 21/67.

ALDO FERNANDEZ, who is referred to in Legat, Mexico airtel, 7/6/67, as person who sent \$200 by cable to **FIORINI** at Mante, Mexico, appears identical with **ALDO FERNANDEZ MIYAR**, born 10/14/21 in Cuba. **FERNANDEZ MIYAR** is husband of **ROSA BOSCH AVILA**, sister of subject Dr. **ORLANDO BOSCH**. *(S)*

On 7/24/67, **FERNANDEZ MIYAR** interviewed and denies any knowledge of **FRANK FIORINI**, aka **FRANK STURGIS**, and claims he did not send \$200 to Mexico.

Miami believes **ORLANDO BOSCH** sent money using name of **ALDO FERNANDEZ**, who lives near **BOSCH** and with whom **BOSCH** could readily make inquiry for return of cabled money if it was not delivered to **FIORINI**.

Bureau is requested to furnish Miami with copy of the cablegram transmitting \$200 to **STURGIS** at Ciudad Mante. *(S)*

Miami will then attempt to locate original presumably sent from Miami.
