On 10/23/64, [redacted] PCI, New Orleans Private Detective (protect identity), advised that he had received information that J. FOLSE ROY had contacted LAWRENCE LORD TAYLOR regarding procurement of gold in Central and South America. [redacted] advised that a confidential source close to ROY had learned that a silver medallion had been made by a New Orleans designer which was to be used as a proof for gold coins to be minted.

La Honduras Texas

On 10/22/64, ED DWYER, an American businessman who has done business in Central and South America, advised that he learned that LAWRENCE TAYLOR was to organize a Malayan Specie Bank in British Honduras and that ROY was in some way connected with this venture along with W. C. FORD, Sunbeam Company, 134 Terrell Plaza, San Antonio, Texas.
