The following individuals have furnished information concerning ROSELLI and will probably be able to furnish additional information about his current activities:

Mrs. RALPH (ELLYN) GORMAN, manager of the apartment house at 1251 North Crescent Heights Boulevard, Los Angeles, where ROSELLI maintains an apartment.

LA 3445-C, who formerly lived in the same apartment house where ROSELLI lived and who, although he has had no recent contacts with ROSELLI, is acquainted with many hoodlums in the Los Angeles area.

It is to be noted that ROSELLI spends most of his time in Las Vegas, Nevada, and is at his apartment in Los Angeles only a few days each month. Mrs. GORMAN has advised he was last in the apartment on 12/13/57. The Salt Lake City Office has advised that ROSELLI has been residing at the Tropicana Hotel in Las Vegas.

In the future, contact will be maintained with Mrs. GORMAN, who has promised that she advise the Los Angeles Office as soon as ROSELLI returns to his apartment. Consideration will be given to the possibility of developing an informant who has access to ROSELLI's apartment through Mrs. GORMAN.
