It should be noted that although this source recognizes that his father has not told him everything he does feel that with his association since childhood with the criminal element in Chicago, having served time in the Illinois State Penitentiary and his continued close association with the Chicago criminal element, he would probably have heard of any such rituals attendant to membership.

Chicago desires only to point out that the operational procedures of this group could very well be different from those which are known in other cities. It is not Chicago's intention to take issue with the information that has been forthcoming from highly reliable sources in New York and Philadelphia simply to point out that this difference may exist.
