HIGHLY-CONFIDENTIAL SOURCE KNOWN TO NYCPD INDICATES A CONTACT ABOUT EASTER 1963 BY LARRY GALLO TO NICK BIANCO IN PROVIDENCE. LARRY GALLO REQUESTED BIANCO TO CONTACT PATRIARCA FOR ASSISTANCE HIS BEHALF.

NY 3104-C ADVISED RECENT PAST THAT LARRY GALLO DESIRES TO "HIT" FRANK BARRANCA, AKA FRANK MARTIN OVER CONFLICT IN NUMBERS OPERATION. BARRANCA ALLEGEDLY WITH GAMBINO FAMILY.

CHARLIE REFERRED TO REBOS COMMUNICATION COULD PROBABLY BE CHARLES LO CICERO, A FORMER ACTING CONSULIERI IN THE MAGLIOCCO (PROFACI) FAMILY, WHO HAS BEEN ATTEMPTING TO NEGOTIATE PEACE FOR PAST TWO YEARS BETWEEN GALLO FACTION AND MAGLIOCCO FAMILY. BUREAU AND BOSTON TO BE IMMEDIATELY APPRISED OF ANY PERTINENT DEVELOPMENTS.
