On 3/6/61, PG 612-C advised that GABRIEL MANNARINO has left the New Kensington, Pa., area for Florida. Informant believes MANNARINO intends to spend a week or so at his house at Surfside, Florida.

It is noted that GABRIEL MANNARINO's house at 8191 Dickens Avenue, Surfside, Florida, purchased in August, 1950, is in frequent use, not only by GABRIEL MANNARINO and his immediate family but by others, including such as former Pittsburgh TH FRANK AMATO.

MIAMI will ascertain whether or not GABRIEL MANNARINO is currently at his Surfside, Florida, residence.

MIAMI will also determine the feasibility of establishing highly confidential coverage on the MANNARINO residence in Surfside.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
