On 3/8/61, PG 612-C advised SA THOMAS G. FORSYTH, III, as follows:

Recently, one RALPH THOMAS, no other identifying information, took about \$2,000 worth of knives, forks and other utensils, all made of aluminum, to KELLY MANNARINO in Florida, reason unknown. There were too many for MANNARINO to use in his home in Surfside, Fla., so KELLY must have a restaurant or other outlet there.

SAM MANNARINO recently visited Florida, and while he was there he did not stop to see his brother, KELLY. This probably means that they are still feuding.

On the same date, PG 612-C furnished SA FORSYTH with a copy of an Empire Treasury Lottery Ticket, obtained 3/3/61, at City News, 859 Third Ave., New Kensington, Pa., a numbers racket outlet operated by TOM LATTOS and his wife, DONNA. At that time, informant stated these tickets are being distributed in the New Kensington area by the "MANNARINO mob."
