The 3/9/61 issue of the "Pittsburgh Post-Gazette," daily newspaper published in Pittsburgh, Pa., page 37, contains an article captioned "Burrell Well is Reported." The article set out that on 3/8/61, the Ken Oil and Gas Company reported completion of a second well, called Ken No. 3, which is initially producing at the rate of 90 barrels of crude oil and 600,000 cubic feet of natural gas per day. The article said the first well, Ken No. 2, -2916 is 2,000 feet northeast of Ken No. 3 and is now producing at the rate of 15 barrels of crude oil and 200,000 cubic feet of natural gas per day. Both wells are said to be located on the farm of Attorney P. K. Jones in Lower Burrell Township, Westmoreland County, Pa. The article concluded that a third well will be drilled on this same tract of land, according to A. J. WISE, President of the company.
