With regard to the case captioned, "LOUIS COHEN, ET AL; ITLT," allegedly involving the MANNARINOs, on 3/20/61, PG 612-C advised SA THOMAS G. FORSYTH, III as follows:

The man who delivers the Empire Treasury Lottery tickets in New Kensington, Pa., area, is one JOHN SHRIGGS, whose car bears Pennsylvania license Y11-979. He formerly worked at the City Club, New Kensington, and also worked in the MANNARINO numbers headquarters office. He is supposed to own half of the gambling card games at the Garibaldi Clubs, but due to a high blood pressure affliction, his brother, name not known, is handling the Garibaldi Club action in his place. Thursday is the day new weekly lottery tickets come out and is the day for deliveries to outlets.

It is noted that Pennsylvania auto license Y11-979 is registered to FRANK CIRIGLIANO, rear 1503 Leishman Avenue, New Kensington.

Pittsburgh indices contain one reference to JOHN CIRIGLIANO, 137-450-43, and none to SHRIGGS. On 9/12/55, PG 557-C advised SA JOHN S. PORTELLA that JOHN CIRIGLIANO, aka., Shrig, then appeared to be the soleowner of record of the City Club, New Kensington.

Pittsburgh will be alert to the possibility that CIRIGLIANO may be transporting the lottery tickets interstate.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
