On 3/27/61 PG 615-C advised SA THOMAS G. FORSYTH, III as follows:

GABRIEL MANNARINO returned to Florida on the evening of 3/23/61, reason unknown.

RALPH L. THOMAS, who lives at 3222 Leechburg Rd., New Kensington, Pa., is commonly known as "SNIFF-SNIFF" due to his habitual nasal sounds. He was at one time employed at the Aluminum Company of America plant in New Kensington but now he operates a midget car racing track near the Camp Joan, Pa., drive-in theater. He is a gambler and is friendly with KELLY MANNARINO. It is rumored in New Kensington that the large quantity of Kensington Ware (aluminum pots, pans and utensils) he took to Florida was "hot."

Pittsburgh will contact Security Officer, ALCOA, New Kensington, to see if any aluminum ware has been stolen in quantity.

Miami will verify GABRIEL MANNARINO's presence in Florida, checking first at his Surfside, Fla., residence.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
