**SYNOPSIS:**

4300 North Marine Drive, Chicago, determined to be permanent day to day residence of GUS ALEX. He resides there with MARIANNE RYAN, well-known Chicago model, under the name "MIKE RYAN." ALEX utilizes 9353 South Spaulding, Evergreen Park, Illinois, the residence of his mother, for a mailing address. ALEX reported to control gambling in the "loop" and South Side of Chicago. After ALEX obtained Bureau automobile license number on 3/17/58, he attempted to obtain registration through contacts in the Chicago Police Department, and Cook County, Illinois, Sheriff's Office. ALEX known to drive seven or eight different cars in past three or four months, at least two believed to be owned by HENRY SUSK, well-known Chicago Automobile dealer. ALEX is close to SIDNEY KORSHAK, "syndicate" attorney. ALEX alleged to own farm and race horses in Midlothian, Illinois, though farm not in his name. ALEX and MARIANNE RYAN traveled to Europe this winter. SUBJECT SHOULD BE CONSIDERED ARMED AND DANGEROUS DUE TO HIS DANGEROUS PROPENSITIES.
