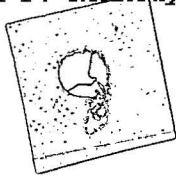

CG SIX FOUR FOUR THREE DASH C ADVISED THAT TONY AND ALEX TORNABENE BROTHERS OF LOUIS <sup>ILL</sup> TORNABENE, <sup>ILL</sup> SANTA FE HOTEL, CHICAGO, PAY ONE HUNDRED TWENTY FIVE DOLLARS A WEEK TO BILL KAPLAN FOR HANDYCAPPING SHEETS AS DOES EACH OUTFIT BOOK IN CHICAGO. THE TORNABENE BROTHERS ARE REPORTED TO BE THE OWNERS OF EDDIE FOY/S LOUNGE, A STRIP JOINT ON SOUTH WABASH, CHICAGO. AGENTS OF THE AT & TU TREASURY DEPARTMENT <sup>ALCOHOL TOBACCO & TAX UNIT</sup> HAVE ADVISED THAT THEY INTEND TO CONDUCT A SERIES OF RAIDS AGAINST OUTFIT OWNED BARS, TAVERNS, AND LOUNGES TO DETERMINE ANY FEDERAL VIOLATIONS OF LIQUOR LAWS EXIST. ON FIVE THREE LAST AGENT OF ATU CONDUCTED A SURPRISE RAID ON EDDIE FOY/S LOUNGE AND WHILE ON THE PREMISES THEY DISCOVERED TEN REFILLED WHISKEY BOTTLES.
