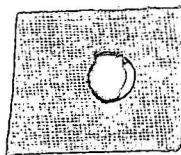

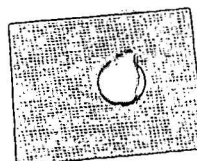

ACTIVITIES OF TOP HOODLUMS
IN THE CHICAGO AREA

TOP HOODLUM PROGRAM

LV 25-C advised SA M. B. PARKER on 9/26/62 that the Plan-It Travel Agency, 6931 West North Avenue, Oak Park, Illinois, which is owned by ANTHONY R. ACCARDO, son of well-known hoodlum ANTHONY J. ACCARDO, and ROBERT NITTI, son of the old-time hoodlum FRANK NITTI, have booked a short convention into the Dunes Hotel, Las Vegas, for an organization known as the Oak Park Fellowship Club. CI advised that this is composed of only those individuals of Italian extraction. CI advised that the group is scheduled to arrive sometime on 10/3/62 by chartered aircraft. They will be in Las Vegas for approximately two days.

CI advised he had received a call from NITTI that in addition to the usual room reservation, he desired a deluxe suite reserved for a "VIP." CI stated that he is not sure but he believes that NITTI stated the name of the VIP was SAM MOONEY.

On the morning of 9/26/62, in the presence of SA PARKER, LV 25-C telephonically contacted NITTI to confirm

that the deluxe suite had been reserved, and CI asked NITTI what name should be used in making the reservation. NITTI replied to reserve the deluxe suite in his name. CI replied "We can do that but do I know the individual who will be using it." NITTI replied "You might know him. You'll see him when he gets there," and would make no other statement.

CI is departing Las Vegas on 9/29/62 to Chicago and points East on convention business and he made a definite appointment to see NITTI in Chicago on the morning of 9/30/62, and at that time will obtain a definite arrival time for the group to reach Las Vegas on the basis that the Dunes Hotel has to provide transportation from the airport to the hotel. Upon ascertaining the arrival time of the chartered aircraft in Las Vegas, CI will telephonically contact SA PARKER from Chicago, at which time he will furnish same and the identity of the individual to use the deluxe suite if he can determine the same.

Las Vegas, upon receipt of the information of the arrival of the aircraft, will take appropriate steps to attempt to identify all of those individuals arriving. If possible, photographic surveillance will be instituted and copies will subsequently be furnished Chicago.

Chicago, if any information developed as to identity of any individual planning to make the above-described trip, should advise Las Vegas since same will be of benefit in attempting to identify those individuals.
