CG SEVEN THREE FIVE THREE -GTE AND CG SEVEN THREE EIGHT SIX -PG POTENTIAL Top Echelon Informant RECENTLY ADVISED THAT GIANCANA REPORTEDLY HAS PERFECTED ARRANGEMENTS WHEREBY SHAH OF IRAN HAS ALLOWED GAMBLING CASINO TO BE OPENED IN TEHERAN, IRAN.

INFORMANTS ADVISED LOUIS LEDERER, FORMER CHICAGO GAMBLING FIGURE WHO HAS REPRESENTED CHICAGO GROUP IN LAS VEGAS FOR PAST TWO DECADES, IS IN CHARGE OF CASINO IN TEHERAN. STATED LEDERER PURCHASED ONE HUNDRED SLOT MACHINES IN LONDON, ENGLAND FOR USE IN CASINO. CASINO IS DUE TO OPEN SEPT. FIFTEEN NEXT.

INFORMANTS STATED GIANCANA USED CONTACTS TO INFLUENCE SISTER OF SHAH OF IRAN TO PERSUADE HER BROTHER TO ALLOW GAMBLING.

ACCORDING TO INFORMATION SHAH WILL NOT ALLOW ANY FOREIGNERS OUTSIDE OF LEDERER AND PERHAPS ONE OR TWO KEY EMPLOYEES.
