CS MEX 287 advised 1/7/71 that subject continues to reside in his home in Cuernavaca, Morelos, Mexico. Subject was in Acapulco, Mexico, on New Year's Eve to attend a New Year's Eve party given by his attorney JORGE CASTILLO. He returned to Cuernavaca the following day. He apparently had traveled to Acapulco only to attend this party. There were 40 to 60 people at the party. He spoke only in general terms about his activities and did not mention any travels. (R) U
