Re Mexico City letter, 6-29-71. (C) U

On 7-13-71, WILLIAM C. DAVIS, Cuernavaca, Mexico (PROTECT), advised that there was no indication that subject had been in residence in the house at Nubes #2 in Cuernavaca, and local rumors were that the owner of this house had left the country and that his house had been sold to a Mexican politician. On 8-18-71, he advised that he considered it confirmed that subject no longer owned the house at Nubes #2 in Cuernavaca. Workmen are swarming over the house, making numerous changes and alternations, and reportedly the house was sold to the former governor of the Mexican State of Chiapas. (C) U

He noted that Mr. and Mrs. BRUCE VICKERS who are presently responsible for the development of the Rancho Tetela section of Cuernavaca, where Nubes #2 is located, have always claimed ignorance of the identity of the occupants of Nubes #2; however, recently, BRUCE VICKERS was heard to comment that he knew it was the subject who had been living at Nubes #2 and, furthermore, that the subject had been "thrown out of the country". No information has been received to confirm this report from contacts in the Mexican Secretariat of Government. These contacts in the past have indicated that (C) U

subject could not be illegally in the country. Since he was known to be in the country, it is obvious that he was wielding influence within that agency. It would appear that this support may have been withdrawn, possibly as a result of the recent change of personnel within that agency. The withdrawal of this support, would, in effect, result in his departure from the country, as commented by VICKERS. (X)u

On various contacts in July and August of 1971, CS MEX 287 said that he had received no information concerning subject and that in general conversations among subject's acquaintances in Mexico, it was considered that he was gone from Mexico and the rumor was that he was in Beirut. (A)u (X)u

On 8-18-71, CS MEX 287 furnished the following information resulting from a conversation of friends and acquaintances known to have been in regular contact with subject during his residence in Mexico: (A)u (X)u

Subject has sold his house in Cuernavaca to a Mexican politician and has left the country. He is believed to be in Beirut. It was not known if he has any plans to return to Mexico. (A)u (X)u

Indications are that he bases out of Beirut but also has been traveling in Europe. (A)u (X)u

Source has been careful not to make any appearance of making inquiry concerning subject but believes that through continued contact with subject's attorney and acquaintances, more specific information concerning subject will develop. (A)u (X)u

Information copies to Legats, Beirut and Rome, because information herein indicates subject may be traversing or living in areas covered by these offices. (X)u
