On 10/6/71 CS MEX 287 furnished the following information: (A) U

It is noted parenthetically that source has not been in personal contact with the subject recently but is receiving this information through mutual acquaintances principally friends of subject's Mexican attorney JORGE CASTILLO (A) U

ON 2/5/96

Subject was definitely recently in Mexico and was believed to be residing in Las Quintas in Cuernavaca. (A) U

He is no longer believed to have any connection with the house on Las Nubes in Cuernavaca and is believed to have abandoned the apartment on Amsterdam Street in Mexico City. He was seen on Saturday, 9/24/71, but was reported to have departed Mexico on the 25th or 26th and supposedly had gone to California. (A) U

On 10/8/71 source advised that subject was back in Mexico as of that date and anticipated that he would have further specific information concerning subject. (A) U

He believed that subject was residing in his home in Las Quintas in Cuernavaca, Morelos, Mexico. (A) U

It is noted that Hosteria Las Quintas in Cuernavaca is a hotel and restaurant. Included in the same complex are a number of private homes. Subject was previously reported to have purchased the home of GERALD SCHULTZ which is in the San Cristobal area. (A) U

On 10/19/71 [MEX 34] advised that on that date he observed a 1970 Ford Galaxie, Mexico, D.F. License KTE 78 parked at Quinta San Cristobal in the Las Quintas colonia in Cuernavaca. (S)X

It is noted that this license plate was previously determined to be registered in the name Los Nubes S.A. known to be subject's company front name for property holdings in Mexico. (S)u (S)(u)

[MEX 34] advised that discreet inquiry indicated that the Quintas San Cristobal was occupied by a man of Jewish appearance named DI PALMA. This is known to be the name subject has utilized in Mexico. (S)X

Information copies to Rome and Beirut who had leads to attempt to establish subject's travel in their areas (S)u
