CS MEX 287 advised 11/3/71 that subject was still in Mexico and staying in Cuernavaca. He personally saw subject in Mexico City casually and did not have a chance to talk to him. (R)U (X)X

However, as of 12/3/71 he heard reports from mutual friends that the subject at that time was on a trip to the U. S., place unspecified. (R)U (X)U

Source advised that he will be in Acapulco over Christmas, 1971, and that while there, he expects to be in contact with subject's attorney and other friends of the subject. He anticipates, as in past years, subject would also be spending Christmas in Acapulco and that he will be in contact with him during this time. (R)U (X)U
