Referenced Bureau cable indicates that RICHARD SCALZETTI, aka Richard Cain, disappeared from the Chicago area 5/1/72 and Chicago believes he may have returned to Mexico to be with subject. (A) V

As reported in the "UNSUB, aka George Ames; Eastern Airline Flight 175, 5/5/72; HIJACKING" case, CAIN's former wife LUZ SALVATORE advised that after no contact for seven years, CAIN unexpectedly contacted her and took her and her family to dinner in Mexico City about the middle of 4/72. He was uncommunicative as to his plans only indicating he continued on to Brazil and Argentina. He made no mention of subject and the only information she had concerning subject was what she had obtained reading the Chicago newspapers. She did not know subject and did not know of any relationship between CAIN and the subject. (A) V

In contacts with MEX 287 he advises that he has had no direct contact with subject for a number of months. He does not know the reason for this and noted that previously there were frequent and friendly contacts with rarely a week going by without a call or a card game or some type of personal contact. (A) V

At present, the only information he received concerning subject is second hand from mutual friends and this is sketchy. (A) V

The only recent information he has concerning subject was that subject was seen at the Churrubusco Golf Club in Mexico City 4/30/72. (A) V
