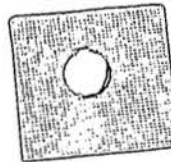
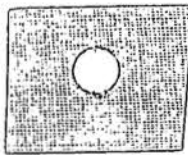

JAMES RUSSELL HAWTHORNE, NORTH WEBSTER, INDIANA, WHO WAS PREVIOUSLY IDENTIFIED AS IN 1961 IN EUROPE WITH SLOT MACHINES, ADVISED DECEMBER 18, 1961, THAT SUBJECT HAD NO CONNECTION WITH SOUTHERN DISTRIBUTING COMPANY, ORLANDO, FLORIDA, AND HAWTHORNE NEVER MADE ANY DIRECT STATEMENTS SUBJECT EVER BACKED HIM FINANCIALLY, AND HAD NO DIRECT WORKING AGREEMENT RELATIVE TO SLOT MACHINES IN EUROPE.

SAM JOHNSON, U S CUSTOMS AGENCY, TAMPA, ADVISED MARCH 20, HE INTENDS LOCATE SUBJECT FOR INTERVIEW REGARDING THE SMUGGLING OF GOLD OUT OF CUBA, WHICH WAS PREVIOUSLY REPORTED, IN EFFORT TO ESTABLISH IF SUBJECT HAD ANY CONNECTION WITH SAME.

[REDACTED] (PROTECT), MANAGER, ROCKY POINT BEACH MOTEL, TAMPA, ADVISED MARCH 20, 1962, THAT LOU BRADY HAD NOT RETURNED TAMPA, FROM CHICAGO, HOWEVER, THERE ARE INDICATIONS THAT THE OWNER OF THE EMBERS, MIAMI BEACH, FLA., MAY BE TAKING OVER THE CONCESSIONS AT ROCKY POINT BEACH MOTEL.
