A source at the General Telephone Company of Florida, Tampa, Florida, on May 16, 1962, advised SA EARL M. PETERSEN, that 876-2207, the non-published number of subject, works in Cable H, pair 386 at rear of 2504 Edgewood. The count here is 383-393. All of these numbers are in use.

The above numbers appear as follows:

H 376-X4 appears at side of 2403 Bristol

B 381-390 appears at side of 2402 Bristol.

Inasmuch as no spare pairs are available, it will not be possible to install an [SPMT] misur at the home of SANTO TRAFFICANTE. It is also not possible at this time to install any other type of misur using wires to exit as no spare pairs are available for leased line service.

The only type of installation would be a radio transmitter which would require a nearby plant. It would be desirable that an AC operated transmitter be used. Should a battery-operated transmitter be used it would last no more than about four to five days. Shortly after this the batteries would be exhausted to the point where they could start leaking acid. For security reasons this would not be desirable.

In view of the above set forth facts, as well as the fact that subject is residing at Miami, Florida, no further action is being taken at this time in captioned matter, but the Tampa Office is pressing for other suitable locations to penetrate subject's alleged organization.
