In view of information contained in referenced Miami letter reflecting that as of 4/24/62, NORBERTO FUENTES GARCIA was located in Havana, Cuba, the specific address for this individual was furnished to the Mexican Immigration Service for the completion of their files.

SANTIAGO IBANEZ LLAMAS, Chief of the Inspection Department, Mexican Immigration Service, on 6/20/62 advised that he was closing out his file concerning FUENTES GARCIA and his agents' efforts to locate him in view of the information received that he was located in Havana as of April, 1962.

In view of the foregoing information, this case is being closed by the Mexico City Office.
