WEEKLY AIRTEL SUMMARY

PETER GIAMPAPA, PCI, advised on 7/24/62, the subject took his 1961 Falcon from his bakery on either the night of 7/24/62, or morning of 7/25/62. GIAMPAPA advised he is the actual owner of this car but he allows the subject to use it when subject is in Miami. He said he keeps this car parked at his bakery and claimed that the subject takes the car without notifying him, then leaves the car parked at the bakery when he leaves town. GIAMPAPA claimed the subject never contacts him when he is in Miami.

Subject was observed on the afternoon of 7/26/62, at the LaHacienda Restaurant, 2795 N. W. 7th St., Miami. The owner of this restaurant is RALPH REINA, who was interviewed on 8/30/61, re his association with the subject.
