On 7/24 and 26/62, PCI (protect), advised subject had no longer been observed nor reported at the Columbia Restaurant, however, his close associate JIMMY LONGO has been at the restaurant on a daily basis.

JACK DE LA LLANA, Intelligence Unit, Tampa Police Department, advised 7/24/62, that his sources close to the subject advise him subject is still reported at St. Petersburg Beach or Thank, or had returned to Miami, Florida.

BASIL SCAGLEONE, brother of NICK SCAGLEONE, advised NICK no longer in the rackets and NICK has not been in contact with the TRAFFICANTES for over three months to his knowledge, and whereabouts of subject therefore unknown.
