Bernard Glickman, former professional fight promoter and associate of Chicago hoodlums Sam Giancana, Anthony Accardo and Felix "Milwaukee Phil" Alderisio, has been under development by our Chicago Office as an informant. 16He has a close personal relationship with heavyweight contender Ernie, Terrell and at present is the music manager for Terrell and his entertainment group. In view of Glickman's reputation of being a front for the mob, he has been instructed by Chicago hoodlums to disassociate himself from Terrell so that Terrell will present a hoodlum-free image and receive a title fight opportunity. According to Glickman, on Friday, January 28, 1966, Terrel and Cassius Clay, the current heavyweight champion, will sign a contract in New York for a title match to be held in Madison Square Garden on March 29, 1966. Terrell allegedly will only receive a flat sum of \$150,000 with no percentage or expenses. In this connection, General Melvin Hrulewitch, Chairman, New York State Athletic Commission, advised that Terrell has applied for a fighter's license in New York State claiming complete disassociation from Glickman. Terrell's opportunity to fight Clay for the title in New York may hinge on whether or not he can get a New York license. Until recently, Julie Jsaacson, New York toymaker union official, was the official manager for Terrell; however, at the fight contract Terrell; signing ceremonies today, Negro theatrical agent Joe Glaser will be acting as Terrell's manager. Glaser, a wealthy agent, who manages Louis Armstrong as well as other high priced Negro entertainers will 'in the future represent Terrell in all of his affairs. Glaser in this capacity is allegedly acting as a front for Felix/"Milwaukee Phil" Alderisio and the Chicago hoodlum group. Glickman states that Terrell is not acquainted with ranking hoodlums in Chicago or New York and is completely unaware of connections of the New York and Chicago underworld in his affairs. Furthermore, Glickman claims to have been threatened by Alderisio to influence Terrell to sign with Glaser for a fight in Madison Square Garden. However, Glickman and Terrell have a private understanding that Terrell will later back out of the contract and refuse to fight for the flat sum of \$150,000 since Clay obviously will be receiving millions in theater, film, television rights and from the live gate.

OBSERVATIONS:

The interest of Chicago and New York hoodlums in fighter Terrell is similar to their previous interest and control over heavyweight Charles "Sonny" Liston. Glickman apparently is being muscled out of any control he may have over Terrell by the Chicago hoodlum group. Obviously, contacts with him must be handled in a most circumspect manner.

ACTION:

This matter is being closely followed and Chicago is conducting inquiries attempting to establish a violation of the Interstate Transportation in Aid of Racketeering - Extortion statute in connection with Alderisio's threats against Glickman.
