PC ADVISED TODAY HE CONFERRED TELEPHONICALLY WITH ERNIE TERRELL WHO INFORMED HIM THAT HE RECENTLY MET WITH HERBERT MUHAMMAD. HERBERT TOLD TERRELL THAT ALTHOUGH HE AND CLAY WENT TO NEW YORK ON EVENING JANUARY TWENTY SEVEN LAST HE FELT SURE THEY WOULD NOT SIGN FOR TERRELL -CLAY FIGHT SINCE TED BERNNER INFORMED HERBERT THAT NY ATHLETIC COMMISSION WOULD NOT ALLOW BRENNER TO GIVE THEATER RIGHTS TO MAIN BOUT, INC., WHICH IS OWNED BY MUSLINS. HERBERT ADVISED TERRELL THAT CLAY WOULD NOT SIGN CONTRACT TO FIGHT IN NY UNLESS MAIN BOUT GIVEN THEATER RIGHTS. PC FEELS BRENNER MAY HAVE PREVAILED UPON COMMISSION TO DENY TERRELL'S APPLICATION IN ORDER TO GET RID OF PC. PC STATED AS FURTHER EVIDENCE OF DOUBLE DEALING OF BRENNER, OBVIOUSLY ACTING UNDER INSTRUCTION OF HOODLUMS, BRENNER PICKED TERRELL UP AT AIRPORT JANUARY TWENTY EIGHT AND TOOK HIM TO COMMISSION OFFICES WHILE ASSURING TERRELL FIGHT WAS ON AND THAT ARRANGEMENTS HAD BEEN MADE TO INSURE THAT TERRELL'S APPLICATION WOULD BE APPROVED.

ILL. PC HAS SUBMITTED TO INTERVIEW DICK HACKENBERG, SPORTS COLUMNIST, CHICAGO SUN TIMES. BESIDES COLUMN FAVORABLE TO PC, HACKENBERG AGREED TO ACCEPT LENGTHY STATEMENT BEING PREPARED BY PC OUTLINING HIS FORMER ASSOCIATION WITH TERRELL AND WITH HIS PRESENT DISASSOCIATION WITH TERRELL. STATEMENT SAYS NOTHING ABOUT INVOLVEMENT OF HOODLUMS OR ANTHING HAVING TO DO WITH THIS INVESTIGATION.

ILL. CG SIX NINE THREE SIX DASH PC ADVISED TODAY HE ACTED AS CUT MAN FOR JOE GLASER WHEN GLASER MANAGED FIGHTERS IN CHICAGO IN NINETEEN TWENTIES. ADVISED GLASER BECAME INVOLVED SOCIALLY WITH CHICAGO HOODLUMS WHEN AL CAPONE FREQUENTED SUNSET NIGHT CLUB OWNED IN TWENTIES BY GLASER. ACCORDING TO THIS PC, GLASER ARRESTED IN LATE TWENTIES IN CHICAGO FOR RAPE OF THIRTEEN YEAR OLD GIRL AND ACQUITTED. OPERATES TALENT AGENCY KNOWN AS ASSOCIATED BOOKING, INC. WITH HEADQUARTERS IN NY. AND OFFICES ALL OVER WORLD. IS CLOSELY ASSOCIATED SIDNEY KORSHAK, ACCORDING TO PC, SINCE KORSHAK REPRESENTS ENTERTAINERS AS THEIR N.Y.
