

the course of investigation being conducted in the case entitled "Criminal Influence in International Teamsters Union, Local 901, San Juan, Puerto Rico, ANTI-RACKETEERING" mentioned above.

Lieutenant ALVAREZ advised that the information was furnished to the POPR by FEDERICOVIRELIA, Public Relations Official of the Local 901 Teamsters Union, who is a paid informant of the Police Department and operating under the cover name of "ACE".

Lieutenant ALVAREZ advised that "ACE" could furnish no other information other than that set out and was unable to furnish any additional details regarding this information.

Because of the informant's position with the Teamsters Union, the POPR is concerned about protecting his identity and believes that if the informant's identity were known, it would be difficult to obtain information of the nature this informant can furnish.

The letterhead memorandum is being marked "Confidential" in that it contains information furnished by "ACE", a confidential informant of the POPR, who is a highly placed Teamsters official and should his identity become known, it will destroy his future effectiveness and may endanger his life.

No local dissemination is being made in that such local dissemination could reasonably result in the identification of the aforementioned source.

Careful consideration has been given to the source concealed and his identity was concealed only in those instances where necessary.

San Juan Office continuing contacts with Lieutenant ALVAREZ and information obtained from him will be reported in pertinent individual cases.
