

With reference to your Los Angeles report dated 1 SEPT 67, attached hereto is a copy of the application form submitted by Mrs. Gertrude ZAROWITZ dated 28 DEC 59 for a Canadian Passport No. 4-953559 which was issued on 29 DEC 59. Also attached is a copy of her application for renewal of the said passport. This renewal was issued on 9 MAR 65 and is valid until 29 DEC 69.

2. The only method of determining if Gertrude ZAROWITZ travelled to Europe during October 65 would be by a physical examination of her passport as the Passport Office have no record of her travels.
