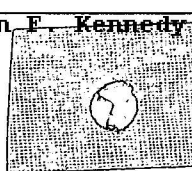

ALLEGED MEETING OF HOODLUMS IN CHICAGO. RECONTACT WITH SOURCES AND INFORMANTS RE OTOP Program ALLEGED MEETING OF HOODLUMS FROM ELSEWHERE IN THIS AREA DID NOT DETERMINE ANY INFORMATION INDICATING THAT OUT OF TOWN HOODLUMS HAVE BEEN MEETING HERE. HOWEVER, CG SIX FOUR FOUR THREE DASH C ADVISED THAT WHEN HE ATTENDED THE WAKE OF ANTHONY L. ALFERVIC, AKA QUOTE RAMEY UNQUOTE AS DESCRIBED IN MYTEL YESTERDAY HE FOUND LESLIE QUOTE KILLER KANE UNQUOTE KRUSE, RALPH PIERCE AND LESSER HOODLUMS, GAMBLERS AND CHICAGO POLITICIANS IN ATTENDANCE. FULL COVERAGE ALONG WITH FIXED AND MOBILE SURVEILLANCES WERE CONDUCTED LAST NIGHT AT THE WAKE OF RAMEY. NEITHER GUS ALEX, MURRAY HUMPHREYS, FRANK FERRARO, SAM GIANCANA OR ROSS PRIO WERE NOTED AS ATTENDING WAKE. IT SHOULD BE FURTHER NOTED THAT TOP HOODLUM MARSHALL CAIFANO ACCOMPANIED BY TWO OF HIS ASSOCIATES WERE ARRESTED BY THE STATE-S ATTORNEY-S OFFICE THIS AFTERNOON EN ROUTE TO RAMEY-S WAKE. HOWEVER, NO DETROIT FIGURES OR OTHER OUT OF TOWN INDIVIDUALS WERE IN CAIFANO-S COMPANY AT TIME OF ARREST THIS DATE. IRS HAS BEEN ADVISED OF CAIFANO-S ARREST. CHICAGO SOURCES AND INFORMANTS HAVE BEEN REQUESTED TO REMAIN ALERT FOR POSSIBILITY OF MEETING OF HOODLUMS. INVESTIGATION CHICAGO CONTINUING. AM COPY TO DETROIT.
