HANNEBERG or whether HANNEBERG is to sponsor these two workers for jobs on another payroll of the City of Chicago through his patronage quota as a Republican Ward Committeeman, but the former is the more likely. The reference to D'ARCO is obviously a reference to JOHN D'ARCO, the Alderman and Democratic Ward Committeeman of the First Ward of the City of Chicago who is generally recognized as the leader of the "West Side bloc." The reference by PORCARO and BLASI to "MOE" and to "MOONEY" are references to GIANCANA.

JIMMY ADDUCCI is a former member of the "West Side bloc" who was a Democratic Ward Committeeman and a member of the Illinois Legislature, who was known approximately a dozen years ago as one of the stronger leaders of the "West Side bloc." He also had powerful hoodlum connections and controlled handbooks in his area on the West Side of Chicago.

The reference to GIROLAMI is obviously a reference to CG 6498-PC, who is generally considered to be a leader of the "West Side bloc", but who has advised that he is making every attempt to combat the influence of GIANCANA and his associates in Chicago politics without making an open issue of it. the above conversation it would appear that GIROLAMI recently refused GIANCANA's suggestion that he make jobs available to PORCARO. It is noted that CG 6498-PC has more patronage jobs available to him than practically any other Chicago politician due to the fact that he not only has 275 jobs under his command as Democratic Ward Committeeman of the 28th Ward but also has 71 jobs under his command as Clerk of the Probate Court. He also is influential in obtaining jobs due to the fact that he is a member of the Cook County Central Committee which is responsible for slating individuals for Democratic nominations in Cook County. PORCARO's reference to the Sheriff would apparently indicate that GIANCANA ordered GRANATA to contact Sheriff FRANK SAIN concerning the two jobs desired for PORCARO but that GRANATA preferred to contact HANNEBERG.

The above is indicative of the control GIANCANA exercises over the leaders of the "West Side bloc."
