GUS ALEX, AKA. AR. DAILY SUMMARY.

CG SIX FOUR FOUR THREE DASH C ADVISED THAT CHICAGO  
MUNICIPAL COURT JUDGE JOSEPH WOSIK WAS BACKED AND PLACED  
IN HIS PRESENT JUDGESHIP THROUGH THE EFFORTS AND FINANCIAL  
BACKING OF GUS ALEX.

ACCORDING TO INFORMANT WOSIK WAS A FORMER REFEREE IN  
TRAFFIC COURT AND WAS RECENTLY APPOINTED TO THE JUDGESHIP  
AFTER CONTRIBUTING THE NECESSARY FUNDS TO THE DEMOCRATIC  
ORGANIZATION IN CHICAGO. INFORMANT SAID IT WAS GUS ALEX  
WHO CONTRIBUTED THE FUNDS FOR JUDGE WOSIK.

INFORMANT SAID JUDGE WOSIK IS PRESENTLY SERVICING  
THE OUTFIT AS INDICATED BY HIS RECENT HANDLING OF THE  
TRAFFIC CASE AGAINST OBBIE FRABOTTA, CHICAGO HOODLUM.  
THE CASE AGAINST FRABOTTA WAS THROWN OUT OF COURT BY  
JUDGE WOSIK BECAUSE OF LACK OF EVIDENCE.
