GEORGE N. SEELT, PCI, ADVISED THAT ALEX DINED AT THE FRENCH ROOM ^{OTHER 4}
OF THE HARTFORD PLAZA RESTAURANT ON AUGUST TWELVE LAST IN THE COMPANY
OF HIS CLOSE ASSOCIATE, EDWARD VOGEL, AND HIS PARAMOUR, SUZANNE
FUEGER, AND VOGEL-S PARAMOUR, PEGGY STRAK. SEELT STATED THE
RESERVATIONS WERE MADE IN THE NAME OF
DOCTOR BROWN AND THAT THE RESERVATIONS WERE TAKEN BY JULES RIESER,
CONTACT FOR ALEX, AT THE HARTFORD PLAZA RESTAURANT.

SEELT STATED THAT ALEX DID NOT OCCUPY HIS USUAL BOOTH AT THE
RESTAURANT AND SINCE HIS PREFERRED WAITER, [REDACTED] PCI, IS NO
LONGER EMPLOYED AT THE HARTFORD PLAZA RESTAURANT, PIERRE SCHMIED
WAITED ON ALEX- GROUP.

SEELT SAID THAT SCHMIED INFORMED HIM THAT ALEX HAD REQUESTED
SCHMIED TO COOK FOR HIM AT HIS RESIDENCE SOME SUNDAY IN THE
FUTURE, BUT SCHMIED DID NOT GIVE ALEX ANY POSITIVE ANSWER TO DATE.
SEELT STATED THAT HE CONSIDERED SCHMIED ENTIRELY TRUSTWORTHY AND KNOWS
THAT HE DISLIKES ALEX AND PERSONS OF ALEX- CALIBER.
