GUS ALEX, AKA. AR. DAILY SUMMARY.

CG 6443-C ADVISED THAT HE HAD LEARNED THAT THE WIFE OF RECENTLY DECEASED ANTHONY RAMIE ALFERVIC RECEIVES APPROXIMATELY \$100.00 PER WEEK FROM THE GUS ALEX ORGANIZATION. HE SAID THAT THE ALEX ORGANIZATION IS APPARENTLY TRYING TO HELP SUPPORT RAMIE'S WIFE AND FAMILY BECAUSE OF LOYALTY IN THE PAST BY RAMIE TO THE ALEX ORGANIZATION. INFORMANT STATED, HOWEVER, THAT AT THE TIME OF RAMIE'S DEATH, RAMIE AND ALEX WERE ACTUALLY AT ODDS WITH EACH OTHER, HOWEVER DUE TO THE FACT THAT RAMIE GREW UP IN THE SAME NEIGHBORHOOD WITH ALEX AND HAD BEEN LOYAL TO ALEX FOR MANY YEARS, THE ALEX ORGANIZATION APPARENTLY DESIRED TO HELP SUPPORT RAMIE'S WIDOW.
