

The Bundeskriminalamt - West German Federal Criminal Police (BKA) has advised that the Munich, Germany, Criminal Police have again interviewed HELMUT FRIEDRICH LEC MAIER in an effort to obtain from him what information he may have regarding the activities of the subject. At that time MAIER told the Munich Police that his employer of the firm LINDE, which produces the LINDE refrigerating equipment, has plans to establish MAIER as its export agent in New York City on October 1, 1962, or at the latest by January 1, 1963.

MAIER declined to furnish information on ALEX at this time to the Munich Police, but asked that the FBI contact him directly upon his return to the United States. He assured the Munich Police that he would furnish them information in advance on his arrival time in the United States and his future address in New York City, so that the Bureau might be informed of this information.

In view of MAIER's statements, this case is being RUC'd in this office at this time. However, an administrative tickler has been set up to follow the Munich Police through the BKA to insure that the information regarding departure and address promised by MAIER is received.
