CG SIX FOUR FOUR THREE DASH C ADVISED THAT SAM KAPLAN HAS RECENTLY TAKEN OVER THE OPERATION OF ANOTHER CHICAGO DOWNTOWN PARKING LOT WHICH WAS FORMERLY OWNED AND OPERATED BY NICK DISPINZA. INFORMANT SAID THAT HE BELIEVES THIS IS ONE OF SEVERAL PARKING LOTS IN WHICH KAPLAN IS FRONTING FOR HOODLUM INTEREST. INFORMANT SAID THAT DISPINZA IS A CLOSE FRIEND OF TONY ACCARDO AND THAT HE IS OF THE OPINION THAT DISPINZA AND ALEX ARE PARTNERS IN SOME OF THE DOWNTOWN PARKING LOTS.
