The BKA (Bundeskriminalamt - West German Federal Criminal Police) furnished following information on 12-28-62:

Criminal Police in Munich, Germany, have determined that Mrs. ELROSE FUEGER, mother of DIETGARD FUEGER, moved on 9-1-62 from #12/5 Rosenstrasse, Munich, Germany, to house #4 in the village of Riederau, near Landsberg am Lech. (About 30 miles southwest of Munich) She purchased this house and presently resides there with her daughter INGRIED PRASSE nee FUEGER, born 8-13-35, and her daughter's husband, GEORGE PRASSE, born 1926. From 12-17-62 to 12-19-62, a woman described as about 30 years of age visited this house. This woman appears to have been DIETGARD FUEGER. As of 12-21-62 this woman was no longer at the Riederau house.

According to information received by the police, GUS ALEX and DIETGARD FUEGER may have spent the Christmas holidays at the Grand Hotel in, Kitzbuehel, Austria. *mc*

A check of hotels in Munich, Germany, failed to disclose any reservations in the name of ALEX; and no reservations can be located in ALEX's name or the name of DIETGARD FUEGER with the Swiss Airlines or Lufthansa Airlines for flights from Munich, Germany, to Zurich, Switzerland, or vice versa. Also no orders have been placed by ALEX with the Selbstfahrer Union in Munich (an association of car rental agencies).

The U. S. Army Operations and Research Detachment was asked to institute confidential communications (both telephone and mail) coverage on the FUEGER address in Munich. That agency had advised that it independently determined that FUEGER had moved to Riederau as reported by the BKA, and that no telephone service was yet in effect at the house in Riederau. Efforts are being made, however, to cover mail and telegraph communications to this address. The agency stated, however, that because Riederau is a small village, it may be difficult to provide full coverage.

The above information regarding subject's reported presence in Kitzbuehel was furnished to Legat in Bern by telephone on 12-28-62.
