Information was received from the Swiss Central Police Bureau (SCPB), Bern, on 1/8/63 as follows:

GUS ALEX, born April 1, 1914, stayed several times at Hotel Baur au Lac, Zurich, Switzerland, during 1958-59. ALEX also stayed at Palace-Hotel St. Moritz some years ago.

Attached is a photocopy of ALEX's letter dated October 19, 1962, addressed to Baur au Lac Hotel, and copy of the manager's reply. Furthermore, enclosed is a copy of a handwritten letter wherein ALEX advises postponement of his visit, to take place on December 21 instead of December 19, 1962.

On December 20 a phone call was made to Baur au Lac Hotel and an apparent friend asked to have cancelled the reservation made by ALEX. Regarding this person, investigations made did not meet with any result.

A thorough investigation was also made at Kloten airport; however, the name of ALEX or FUEGER could not be traced. Also on the days after December 22, 1962 (expected arrival date of ALEX), the passengers' lists of the planes from New York and Chicago were checked but without success.

The SCPB stated that any further information received by them would be furnished this office.

A recontact with Dr. WALTERSKIRCHEN of the Austrian General Directorate for Public Safety revealed that results from the investigation being conducted in the vicinity of Kitzbühel had not yet been received but that the matter was being expedited.


