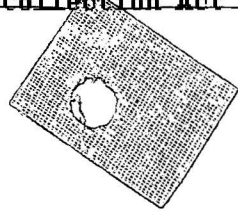
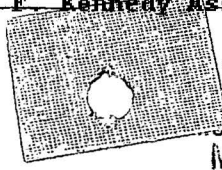

CG SIX FIVE ONE TWO DASH C DASH TE, ADVISED THAT IN A RECENT CONVERSATION WITH SAM PAREN LNU ENPAREN, OWNER OF THE EAGLE GRILL, SAM MENTIONED TO HIM THAT HE WAS FORMERLY A WAITER AT BINYONS, FRITZEL-S AND THE BLACK ORCHID RESTAURANTS, AND KNEW ALEX FROM FREQUENTING THESE RESTAURANTS. SOURCE ADVISED THAT HE KNEW NOTHING CONCERNING THE CARD GAMES IN WHICH ALEX WAS ALLEGEDLY INVOLVED IN THE PAST AT FRITZEL-S RESTAURANT.
