The Swiss Central Police Bureau furnished the following information received from the Cantonal Police in Chur, Graubunden, Switzerland:

It has been established that ALEX stayed at the Schloss Hotel in Pontresina between December 22, 1962, and January 3, 1963, together with his girlfriend, presumably SUZANNE FUEGER, born December 3, 1938. Note of Arrival No. 24508 shows that they were accommodated in room 217 and 218.

Due to a misunderstanding by the Secretary of the local Tourist Office, the Note of Arrival was classified under the name of GOS. This was partly the reason why ALEX could not be traced during the investigations carried out between Christmas 1962 and New Years. On the other hand, this failure was apparently also due to the fact that the exact whereabouts of ALEX were not known and that St. Moritz and other winter sport centers in the neighborhood are usually overcrowded at that time of the year.

It has also been established that ALEX arrived in Pontresina on December 22, 1962, by car, possibly a "Volks-wagen 1500," registration number LU (Lucerne) 29044.

During his stay in Pontresina ALEX had private skiing lessons by two local ski instructors and, according to the staff of the Schloss Hotel, he did not mix with other guests at the hotel.
