Enclosed herewith are six copies of an LHM for dissemination to Legat Rome and the Italian National Police (INP). (u)

A confidential Chicago source, who has furnished reliable information in the past, advised on 10/29/71 that ANTHONY ACCARDO was not in Chicago, however, this source had no information concerning his whereabouts. (u)

On 10/29/71, a confidential source connected with the Passport Agency, Chicago, Illinois, advised that NICK NITTI was then on a trip to Europe. This source had no further information regarding NITTI's travel, which is not unusual and no connection was made by the Chicago Division between ACCARDO's absence and NITTI's travel to Europe. (u)
