GUS ALEX, AKA., AR. DAILY SUMMARY. CG SIX FOUR FOUR THREE DASH C ADVISED THAT PAT MARCI, SECRETARY OF FIRST WARD ALDERMAN JOHN DARCO, WHO IS A CLOSE FRIEND OF SUBJECT, IS NOW A PARTNER IN THE OWNERSHIP OF THE ATHENS CAFE WITH ONE SPIROS KARA, WHO FORMERLY OWNED THE NORMANDY RESTAURANT. HE STATED THAT MARCI BOUGHT OUT THE PARTNERSHIP INTERESTS OF STEVE TOMARAS, KNOWN CHICAGO JEWEL AND FUR THIEF. INFORMANT STATED THAT LOUIS ARGER, STATE STREET STRIP JOINT OPERATOR AND CLOSE SOCIAL AND BUSINESS ASSOCIATE OF ALEX, RECENTLY INVESTED TEN THOUSAND DOLLARS IN THE COSMOPOLITAN INSURANCE COMPANY LOCATED ON NORTH SHERIDAN ROAD, CHICAGO. THE MONEY WAS INVESTED IN THE STOCK OF THAT COMPANY AND HE BELIEVED THAT ARGER PROBABLY PURCHASED THE STOCK UNDER HIS WIFE-S MAIDEN NAME, MARY PITTAS. INFORMANT STATED THAT JOHN PITTAS, BROTHERINLAW OF LOUIS ARGER, OWNS AN INTEREST IN THE HOLIDAY LOUNGE ON SOUTH STATE STREET AND HIS PARTNER IS LOUIE ARGER. IN ADDITION PITTAS ALSO OPERATES A HOT DOG STAND KNOWN AS THE ARCADE WHICH IS LOCATED AT CONGRESS AND STATE STREETS. INFORMANT
