REMYTEL JUNE TWENTYTHREE LAST STATING W. RUSSELL ARRINGTON, EVANSTON, ILL., IS A SUBSTANTIAL OWNER OF STOCK IN THE ALBERTO DASH CULVER CO. ILL. STATE SENATOR ARTHUR R. GOTTSCHALK WAS CONTACTED UNDER A SUITABLE PRETEXT AND ADVISED THAT SENATOR ARRINGTON IS AN ASTUTE POLITICIAN WHO ENJOYS CONSIDERABLE POWER AND INFLUENCE WITHIN HIS OWN DISTRICT OF ILL. HOWEVER, HE HAS MADE NUMEROUS POLITICAL ENEMIES IN THE ILL. STATE LEGISLATURE BECAUSE OF HIS EGOTISTICAL AND UNCOMPROMISING POLITICAL PRINCIPLES. GOTTSCHALK STATED THAT IN HIS OPINION SENATOR ARRINGTON IS COMPLETELY HONEST AND RELIABLE AS FAR AS HIS INTERESTS ARE CONCERNED.
