GUS ALEX, AKA. AR. DAILY SUMMARY. PCI [REDACTED] ADVISED HE  
IS AN EMPLOYEE OF THE LAKE SHORE MANAGEMENT CORP. AND IS CHIEF OF  
MAINTENANCE AT THE APARTMENT BUILDING LOCATED AT ONE ONE FIVE ZERO  
NORTH LAKE SHORE DRIVE. HE STATED THAT HE IS ACQUAINTED WITH THE  
SUBJECT AND KNOWS HIM TO RESIDE IN APARTMENT TEN C OF THE ONE ONE FIVE  
ZERO BUILDING. HE HAS OCCASIONS FROM TIME TO TIME TO VISIT THE SUBJECT/S  
APARTMENT FOR MAINTENANCE REPAIR WORK, AND THAT HE RECENTLY WENT  
TO HIS APARTMENT ON FOUR CONSECUTIVE DAYS IN ORDER TO FIX A DRAIN  
IN THE SUBJECT/S BATH TUB. ON ALL OF THESE OCCASIONS HE WENT TO THE  
APARTMENT AT APPROXIMATELY EIGHT FORTY FIVE AM AND THAT HE HAD PREVIOUSLY  
NOTICED IN THE PAST THAT IT WAS THE SUBJECT/S PROCEDURE TO LEAVE HIS  
APARTMENT AT ABOUT NINE THIRTY AM EACH DAY. ON EACH VISIT TO THE  
APARTMENT THE SUBJECT ALWAYS REQUIRED HIM TO FULLY IDENTIFY HIMSELF  
PRIOR TO OPENING THE DOOR. HE STATED THAT IT IS HIS OPINION THAT THE  
SUBJECT/S APARTMENT IS DECORATED ELABORATELY AND THAT THE SUBJECT HAS
