GUS ALEX, AKA., AR, DAILY SUMMARY. CG SIX FOUR FOUR THREE DASH C

RECENTLY ADVISED THAT DR. ROSS MILLER, IN CHARGE OF NORTHWESTERN UNIVERSITY AT EVANSTON, ILL., IS A VERY GOOD FRIEND OF THE SUBJECT AND ROCCO FISCHETTI, CHICAGO TOP HOODLUM. HE STATED THAT FISCHETTI OWNS A PARCEL OF PROPERTY LOCATED ON THE NORTHWEST SIDE OF CHICAGO AND THAT SEVERAL YEARS AGO FISCHETTI SOLD OUT TO NORTHWESTERN UNIVERSITY AT THE PRICE HE PAID FOR THE PROPERTY YEARS BEFORE. THIS PROPERTY WAS SOLD AT THE LOW PRICE IN ORDER TO DO A FAVOR FOR DR. MILLER AND THE UNIVERSITY. INFORMANT STATED THAT FISCHETTI OWNS MUCH OF THE PROPERTY WHICH IS LOCATED NEAR THE NORTHWESTERN UNIVERSITY CAMPUS AND MAY HAVE SOLD THE PROPERTY TO THE UNIVERSITY IN THE MAIDEN NAME OF HIS WIFE. HE STATED THAT THE PROPERTY AT THAT TIME WAS VACANT AND THE SALE TOOK PLACE THREE OR FOUR YEARS AGO. INFORMANT STATED THAT THIS INFORMATION CAME FROM LESTER KRUSE, A CLOSE ASSOCIATE OF SUBJECT ALEX, AND ALEX TOLD HIM THAT FISCHETTI IS A VERY WEALTHY MAN BECAUSE OF THE VALUABLE PROPERTY HE OWNS NEAR NORTHWESTERN UNIVERSITY. DR. MILLER, PRESIDENT OF NORTHWESTERN UNIV., ADVISED BUREAU AGENTS THAT HE WAS NOT ACQUAINTED PERSONALLY WITH THE SUBJECT OR FISCHETTI. HE STATED THAT APPROXIMATELY THREE YEARS AGO A FRATERNITY ATTEMPTED TO BUY PROPERTY IN WHICH FISCHETTI WAS RESIDING AFTER A SIX THOUSAND
