CG SIX FOUR FOUR THREE DASH C ADVISED THAT EDDIE VOGEL IS A VERY INFLUENTIAL PERSON AT THE FIRST COMMERCIAL BANK LOCATED ON THE NORTH SIDE OF CHICAGO. VOGEL IS A CLOSE ASSOCIATE OF ALEX AND ALEX IS ON VOGEL/S PAYROLL FOR THE AJAX PHONOGRAPH CO. AND DELUXE CIGARETTE SERVICE AT A SALARY FOR NINETEEN SIXTY OF TWENTY SIX THOUSAND FIVE HUNDRED DOLLARS. INFORMANT ADVISED THAT HE HAD TALKED TO BANK OFFICIALS OTHER THAN THE PRESIDENT OF THE BANK AND THESE OFFICIALS ADVISED HIM THAT VOGEL FREQUENTLY COMES TO THE BANK ESPECIALLY ON SAT. AFTERNOONS WITH BUTCH MADON, CHAUFFEUR FOR ALEX, AND ROCCO POTENZO, CLOSE ASSOCIATE OF SAM GIANCANA, AT WHICH TIME THESE PERSONS MOVE AROUND THE BANK AS THOUGH THEY OWNED IT. INFORMANT STATED THAT THEY SIT IN THE OFFICES OF THE PRESIDENT AND THAT THE BANK EMPLOYEES APPEAR TO BE FRIGHTENED BY THESE INDIVIDUALS. INFORMANT STATED THAT HE HAD RECENTLY CONFERRED WITH GEORGE BIEBER, ATTORNEY FOR THE FIRM OF BIEBER AND BRODKIN, BOTH OF WHOM REPRESENT INTEREST OF ALEX AND OTHER CHICAGO HOODLUMS AND THAT BIEBER HAS PERSONALLY ADVISED
