ALEX, AKA, AR. DAILY SUMMARY. CG 6443-C ADVISED THAT HE HAD RECENTLY VISITED DOLPHIN MOTEL LOCATED ON GOLF ROAD, GLENVIEW, ILLINOIS AND HAD THE FOLLOWING CONVERSATION WITH MAC LIBBY, MANAGER OF THE RESTAURANT AT THE MOTEL. WHO WAS FORMERLY ASSOCIATED WITH LEWIS TORNABENE, IS NO LONGER CONNECTED WITH THE OPERATION OF THE DOLPHIN MOTEL. PROMOTED THE MOTEL THROUGH AN INDIVIDUAL KNOWN AS FNU YUCTMAN. NEWMAN HELPED TO SET UP THE MOTEL BY FURNISHING IT WITH EQUIP-MENT AND SUPPLIES AND EXPECTED THAT HE WOULD BE PERMANENT IN THE OPERATION OF THE MOTEL, HOWEVER, 60 DAYS AFTER THE OPENING YUCTMAN THREW NEWMAN OUT OF THE OPERATION OF THE MOTEL.
